1988

Dr. Jon J. van Rood and Dr. John Goldman establish the Bone Marrow Donors Worldwide (BMDW), a book with HLA-typing of voluntary donors that transplant centres could use to find a match for their patients.

1994

WMDA was founded by Dr. John Goldman (United Kingdom), Dr. Edward Donnall Thomas (United States) and Dr. Jon J. van Rood (the Netherlands). A first scientific publication on international exchange of cells was published.

1997

WMDA starts to collect data on the number of unrelated transplants and key performance indicators of registries, known as the WMDA Global Trends Report.

2003

WMDA starts to analyse the serious adverse events and reactions occurring in donors and patients, which has grown into the leading biovigilance reporting service for unrelated stem cell donation.

2004

WMDA Standards are published and the first WMDA certified organisation is awarded.

2010

WMDA published white papers to describe the ecosystem of registry operations and the future. The WMDA committees actively develop services to help registries with their operations.

2015

World Marrow Donor Day was launched as an annual day to thank donors globally.

2017

WMDA merged with BMDW and NetCord. Following this, WMDA started to operate the global database with all potential cell sources for patients in need of a transplant.

2021

EMDIS was integrated into the WMDA and the development of a platform to facilitate transplant communication between registries was initiated. WMDA launches a Cell & Gene Therapy Committee.

2022/ 2023

WMDA strengthened its position on donor care by also stepping into the area of cell & gene therapy.

NEW WMDA MEMBERS



The Ukrainian Bone Marrow Registry became a provisional member in March 2023. On 31st December 2023, the registry listed 11,290 donor records.



SPEAR COMMITTEE & REPORTING SERVICE

WMDA hosts an online reporting system for reporting of adverse events and reactions (SPEARs) related to stem cell donation by unrelated and related donors or affecting product quality. With the SPEAR system, we aim to provide insight into the frequency of complications and, if possible, the opportunities to prevent them.

After close collaboration with a user interface and experience designer, 2023 marked the year where a new design of the SPEAR service was released. This redesign intends to enhance the user experience, making it easier for reporters to submit reports and for committee members to carry out their assessment through the reporting tool.

In 2023, WMDA focused on reinforcing security measures to safeguard the sensitive patient and donor data present in the SPEAR service by implementing multi-factor authentication.



Four educational bulletins were disseminated by the SPEAR Committee, aiming to share knowledge and best practices related to adverse events, donor safety, and considerations for donor care:

- 1. Labelling Errors (February 2023)
- 2. Near-Miss Donation (February 2023)
- 3. Unnecessary Donations (August 2023)
- 4. Subdural Haemorrhage (August 2023)

Publication on SARS-CoV-2 Adverse Events

In 2023, the SPEAR Committee published a paper on SARS-CoV-2-related adverse events. They found no severe donor illnesses or SARS-CoV-2 transmission to recipients. Common issues included unused cells, product cryopreservation, and technical problems. Lessons emphasised confirming recipient eligibility, reducing collection-to-transplantation time, and using validated viability assays. The outcomes of the report were presented at the EBMT Annual Meeting.

DONOR MEDICAL SUITABILITY

The Donor Medical Suitability Committee has been working on the project to review the existing pages, 63 unique pages were reviewed and 27 were identified to require an update (minor or major). This project is ongoing. Updated guidance was published on: alcohol intake, hypertension, syphilis and gout.

CELL & GENE THERAPY COMMITTEE

The Cell & Gene Therapy (CGT) Committee published guidance documentation (incl. template) on donor consent for the donation of cells for purposes other than traditional HSCT donation. This guidance aims to provide registry members with the tools to address consent and the sharing of research information in the right manner, at the right time, and in the right format. This document can be adapted to local regulations (2023 WMDA Cellular Therapy Committee - Consent Working Group Output.pdf).

Donor Selection and Cell Source Summit

Session title: Exploring Regulatory Considerations for Genetic Engineering of Immune Cells & Donor-Derived Material. Representative of the WMDA CGT Committee and President-Elect Jay Feinberg presented on behalf of WMDA.

MEDICAL COMMITTEE

The Medical Committee focused on several projects:

- 1. Donor genetic findings (completed): this project aimed to establish recommendations on when and how to disclose donor genetic findings; considerations for genetic counselling and informed consent. The publication provides these recommendations alongside a framework to aid in registry decision-making when genetic mutations of potential donor origin are identified. This includes guidance on pre-donation consenting, post-donation testing of recipients and informing and managing donors when findings of potential donor origin are identified in recipients post-transplantation, aimed at protecting the health, rights, and wellbeing of the donor.
- 2. Experiences of unrelated donor registries in related donor care (ongoing): focused on exploring similarities and differences in providing care to related donors among unrelated donor registries, a survey was shared to collect input. A paper presenting best practices based on these experiences is expected in early 2024.
- 3. Donor Mental Health Assessment (newly started): aims to expand mental health assessment globally, by gathering data from registries on donor mental health assessment practices, surveying donors and donor centre representatives about their experiences, and contributing to standardised recommendations for assessing donor mental health. This is multi-year project.

ADVOCACY

WMDA has been actively involved in discussions surrounding the European Commission's proposal to enhance safety and quality of substances of human origin (SoHO), through the SoHO Regulation. This regulation would address rapid technological advancements in processing blood, tissues, and cells with a future-proof regulatory framework with an emphasis on harmonisation and safeguarding EU benefits from expert guidance for substances of human origin.



WMDA'S CONTRIBUTION TO THE SOHO REGULATION DISCUSSIONS

Towards the end of 2023, final discussions on the texts took place and we hope to see the regulation accepted in early 2024.

WMDA actively engaged in shaping the European SoHO regulation, participating from public commentary the draft release to in-person meetings with MEPs

WMDA participated in shareholder consultations for evaluating current EU directives, collaborating with various stakeholders

WMDA launched communication efforts to encourage national involvement among WMDA membership

WMDA is actively engaged in several other collaborative initiatives and advocates for donor care in various engagements:

- 1. Stakeholder in the EU project: Recommendations and Guidance for the Management of SoHO in hospitals (ReaderSHip Project)
- 2. Participant in the Global Convergence in Transplantation Summit in Santander
- 3. Participant in the annual FDA Cell Therapy and Liaison Meeting (CTLM)
- 4. Stakeholder in the EU project: Egalite that aims to develop an European accreditation program for Substances of Human Origin
- 5.Observer of the steering committee of <u>CD-P-T-O (Council of Europe)</u> that aims to develop ethical, quality, and safety standards in the field of cell transplantation



ENHANCING DONOR CARE THROUGH UPDATED STANDARDS

At the heart of our mission lies a deep commitment to the well-being of our donors. WMDA 2024 Standards are part of WMDA's perseverance to enhance donor care.

1. Focus on Standardisation: WMDA 2024 Standards are a collaborative effort to ensure that the Standards reflect best practices, scientific progress and are aligned with the evolving needs of our community. WMDA 2024 Standards have been updated by incorporating input from both membership and stakeholders. Standards are the fundamental pillar of the WMDA Certification Program.

2. Key Updates Implemented:

- 2 revised Standards on Infectious Disease Markers (IDMs) and addition of 1 Standard: to align current medical testing requirements and to improve operations
- New IT Standard: to improve quality of the donor database reducing the potential for requesting an unavailable donor or missing the optimal donor for a patient
- Addition of 3 new Standards and 1 revised Standard on backup donors: to improve donor counselling and donor safety and well-being.
- 5 new and revised Standards changed on verification typing: to clarify the timing and requiring verification typing of the potential recipient to improve donor and patient safety and improve operations
- 3 new Standards on sharing basic patient outcome data: to comply with regulatory requirements and improve product quality

The WMDA 2024 Standards reinforce the pledge of the WMDA to prioritise donor well-being while continuing to protect patients and promote best practices through standardisation.

ISO 17065 IMPLEMENTATION PROGRESS

To further build on our commitment to continual improvement and excellence, the WMDA is working on the implementation of the ISO 17065 Conformity Assessment - Requirements for Bodies Certifying Products, Processes and Services Standard for the WMDA Pillar 4 Certification Body.

The implementation of the ISO 17065 Standard remains a cornerstone of our organisational framework, as it remains a strategic aim, to enhance the recognition of the WMDA Certification Body by regulators worldwide. We have integrated ISO 17065 requirements into all WMDA certification processes, fostering a culture of efficiency, consistency and quality.

This key project is now in the internal audit phase. This audit, being carried out by an auditor external to WMDA, offers a comprehensive evaluation of the readiness to meet accreditation requirements by providing a thorough assessment, verifying compliance and identifying areas for improvement.

Despite our progress, several challenges were encountered during the ISO implementation journey:

- Change management: improved processes and procedures required extensive communication and training, and the engagement of registries and reviewers
- Resource constraints: limited resources posed challenges in fully executing ISO implementation plans and maintaining compliance

Despite challenges, our achievements underscore the tangible benefits derived from adhering to the ISO 17065 Standard. Looking ahead, we remain dedicated to upholding the highest standards of quality, driving continual improvement across our community for the benefit of donors and patients.

WMDA SEARCH & MATCH SERVICE

- WMDA shares donor and cord blood data with search coordinators and transplant coordinators to assist them with the process to select the best possible stem cell source for their patients
- An unique global dataset: WMDA has a combined dataset from 57 different countries, originating from 102 organisations



Unrelated HPC Marrow, HPC Apheresis and HPC Cords shipped worldwide 1997-2023







HOW WE MANAGE DATA

DATA SECURITY

WMDA facilitates its members by providing tools to ensure compliance with international security standards. This is achieved with the support of the WMDA Security & Privacy Committee. The tools are as follows:

- Data Transmission and Use Agreement: a legal contract that is signed by all listing organisations. The agreement is designed with international privacy law harmonisation in mind and uses common principles and terminology that is consistent or complimentary to national privacy laws
- A set of security standards that are implemented in the WMDA Certification Programme
- A Peer Review service for registries that are not yet certified through the WMDA Accreditation Programme
- In 2023, WMDA staff was upskilled to take more responsibility for professionalisation of data security and privacy within the organisation





MULTI-FACTOR AUTHENTICATION

WMDA staff and users of the WMDA Search & Match Service can only access the information through multi-factor authentication (MFA). This security update was implemented when the new version of the WMDA Search & Match Service went live in July 2022. As registries are providing complete datasets on their donor and cord blood data, it was important to implement additional security measures. In 2023, the SPEAR reporting tool also benefitted from MFA. The end goal of MFA across WMDA applications is to provide our members with a Single Sign-On portal.

TREASURER'S STATEMENT

Income statement

We recorded a negative result of €40,308 compared to a projected loss of €106,047.

The total income amounted to €2,392,673, marking a 40% increase from 2022. However, 18% of the increase is ascribed to licensing fees and meeting income with an equal increase in direct costs. Bad depts rose from €4,865 to €14,885, although this was better than anticipated, partly due to payment difficulties with sanction countries.

Direct costs totalled €923,203. These costs, primarily consisting of hosting costs and licensing fees for the matching algorithm - all related to Search, Match & Connect, were up by 43% in comparison to 2022, but following budgeted costs in view of the parallel increase on the income side. Cost of staff went up by 44% and was 6.3% higher than expected. This increase was primarily driven by strengthening the Certification Body, Pillar 4 (€39K), building contingency within the internal Information Technology team (€153K) and expanding the team with Finance & HR staff (€190K). The increases were in line with the budget, except for Finance & HR staff expenses, which were affected by higher recruitment costs than expected and the fact that the external services were not transferred to internal staff.

WMDA is grateful to DKMS, Anthony Nolan and NMDP for supporting WMDA financially by paying for the maintenance & hosting costs of the matching algorithms (Hap-E and ATLAS). WMDA organised an International Donor Registry Conference (IDRC), which was expertly supported by DKMS. WMDA is also grateful to NMDP for hosting the Midterm Meeting prior to the ONE Forum in Minneapolis.

Other administrative costs, such as travel and external administrative fees, were lower than expected, partially offsetting the higher direct and staffing costs. Deferred ISO certification saved approximately €35K.

TREASURER'S STATEMENT

Balance sheet

Despite the 2023 loss, reserves remain sufficient to cover ordinary operational risks. The resistance equity ratio, defined as free reserves divided by revenue, stands at 30.6%, considered healthy for organisations with a comparable risk profile (15%). Allocated reserves amount to €963K for the continuity, the Certification Body, website and Search, Match & Connect.

Risks

While inflation normalised in Europe in 2023, uncertainties persist due to the conflict in Ukraine, migration, and climate changes. The most significant risk involves the development and transition to new Match-Connect services, increasing global reliance on WMDA. Robust systems must prevent downtime, interruptions, and maintain the highest security standards.

Future

The WMDA continues to strengthen and professionalise with new hires (data protection officer, medical advisor to strengthen SPEAR, support Pillars/CEO) and active engagement from volunteers serving as reviewers for the Certification Body, committee members, IDRC organisers, or leadership of the organisation. The expertise of the volunteers is invaluable for organisational growth.

The expected dependence on new Match-Connect necessitates a reinforced management structure and operational oversight. The WMDA Board is moving towards a two-tier managing Board to ensure robust oversight and control while retaining membership involvement.

Given accumulated losses and anticipated cost increases, the WMDA Board revamped the fee structure. The membership approved the new fee structure in December 2023, aiming for a closer alignment between costs and burdens. As dependency on Match-Connect grows, a pay-per-use fee

model ensures fairness and safeguards the financial positions of smaller and emerging registries.





FINANCIAL REPORT



WMDA INCOME



SPECIFICATION OF WMDA INCOME 2022




SPECIFICATION OF WMDA INCOME 2023

WMDA STRATEGY 2023-2028

WMDA has recently unveiled its Strategy for 2023-2028, marking a pivotal moment amidst a landscape characterised by volatility, uncertainty, complexity, and excitement for both WMDA and its members. This period presents an unprecedented demand for WMDA's services, underscored by a growing and evolving community. Two priority themes emerged from initial work undertaken by the WMDA Board:
