92% response rate




102 organisations in 60 countries

Global inventory of unrelated donors/CBUs available for transplantation 1997-2024





New unrelated donors/CBUs added to the global inventory in 2024




Age and sex distribution of unrelated donors in 2024


HPC Apheresis shipments

Shipments (BM/PBSC) per continent 2023 vs 2024






National vs international shipments (BM/PBSC) in 2024

North America -4 (-1%)






