94% response rate

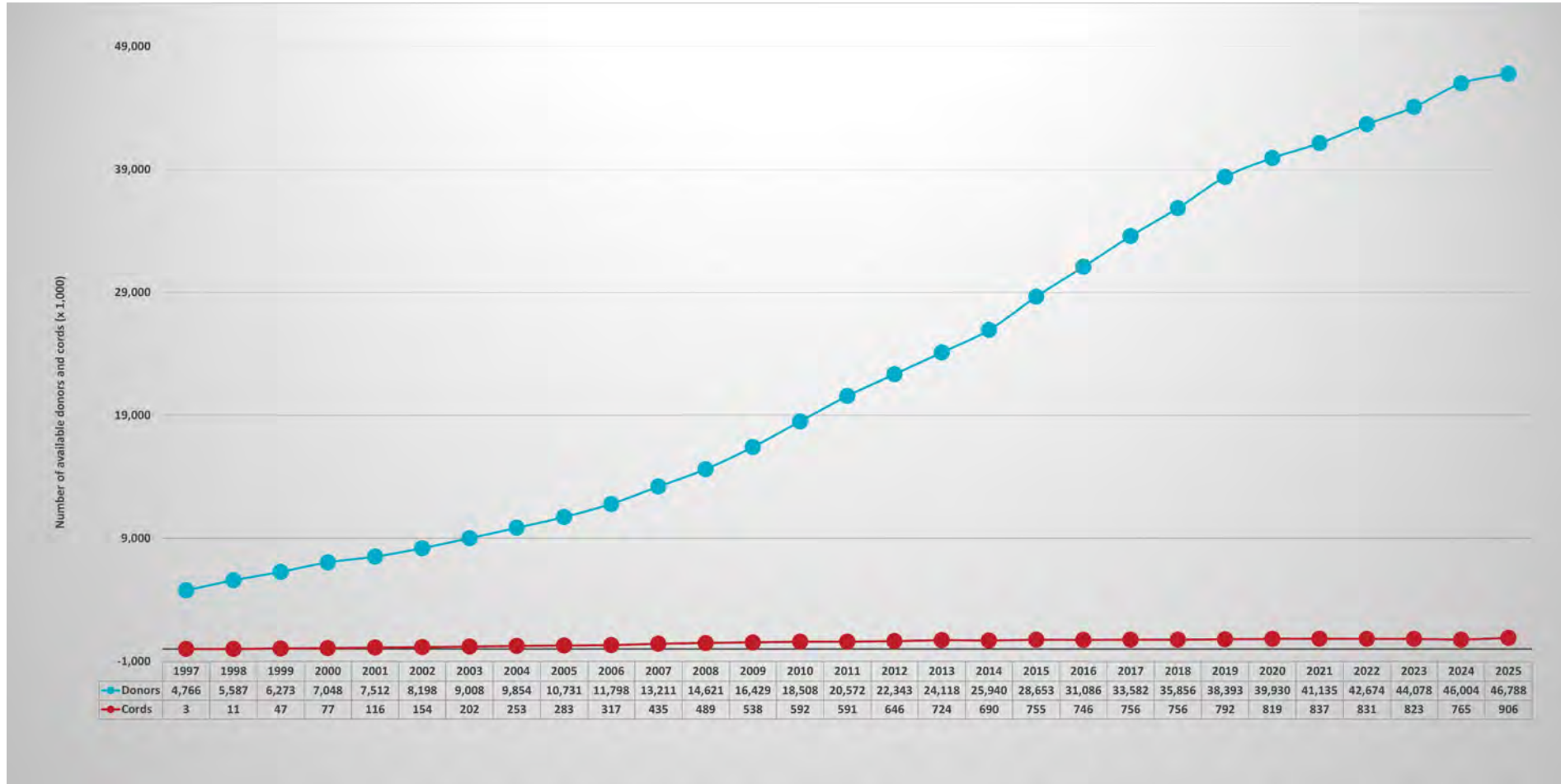


103 organisations in 61 countries

Global inventory of unrelated donors/CBUs available for transplantation 1997-2025

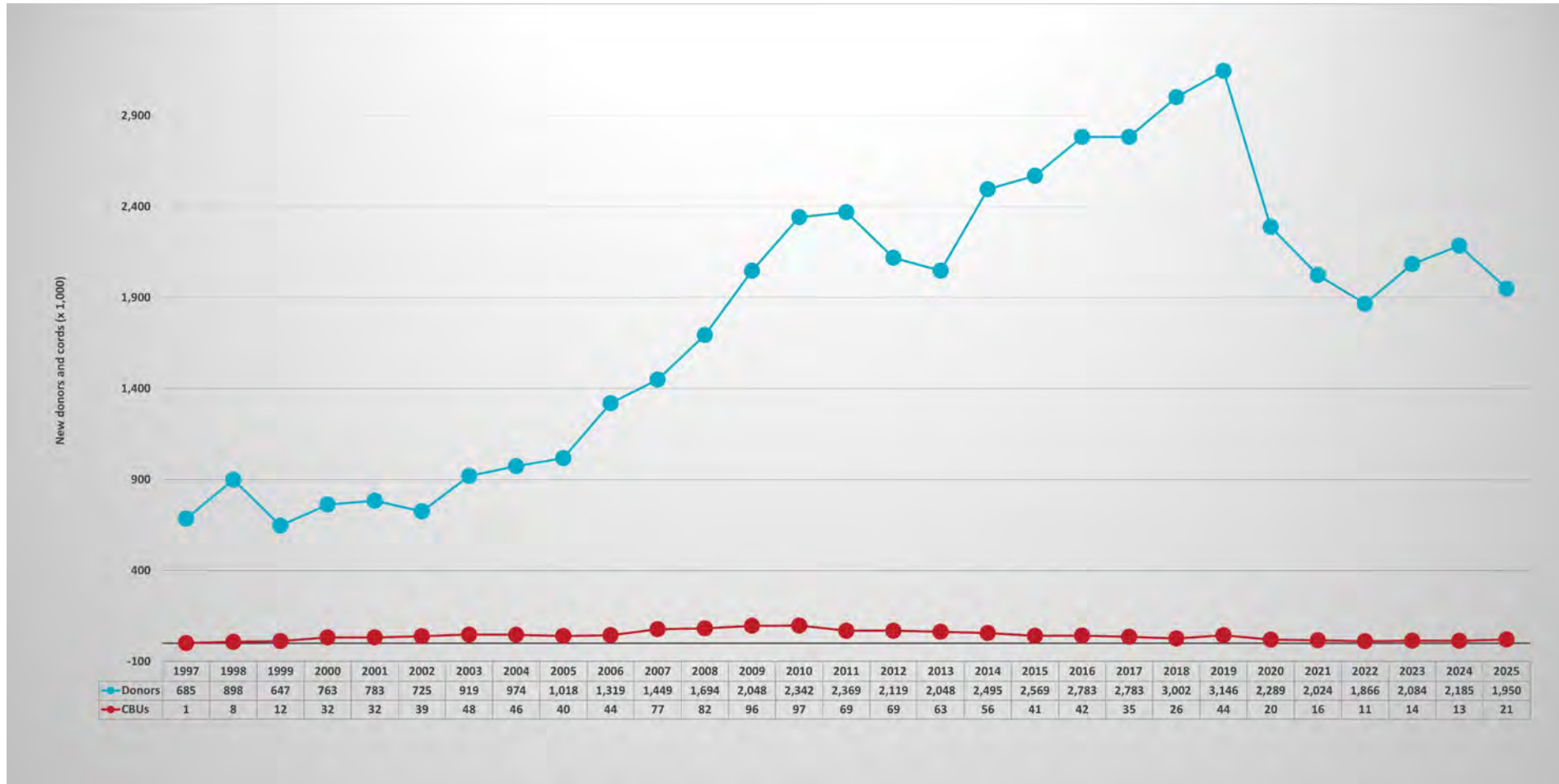

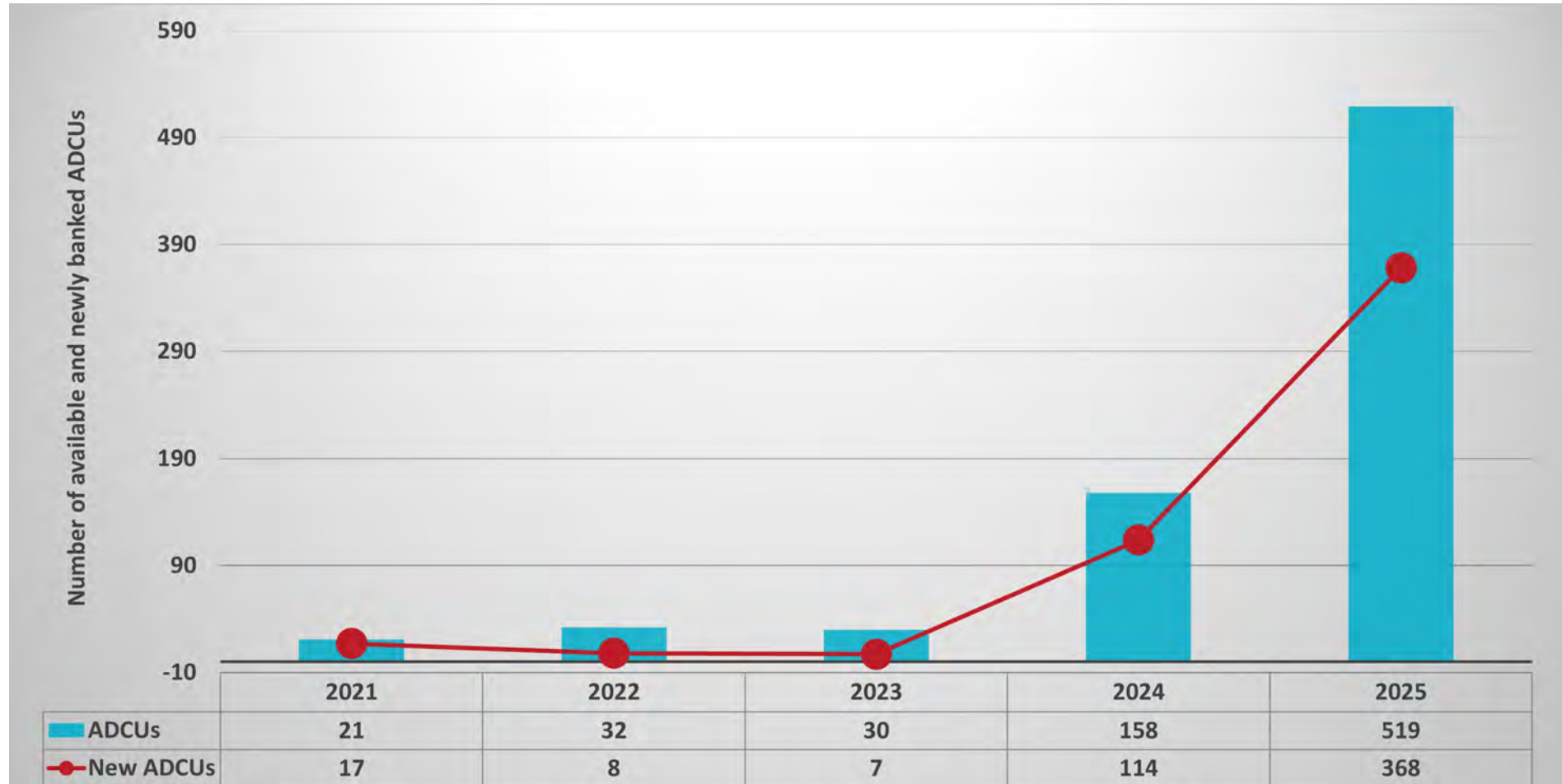
New unrelated donors/CBUs added to the global inventory in 2024



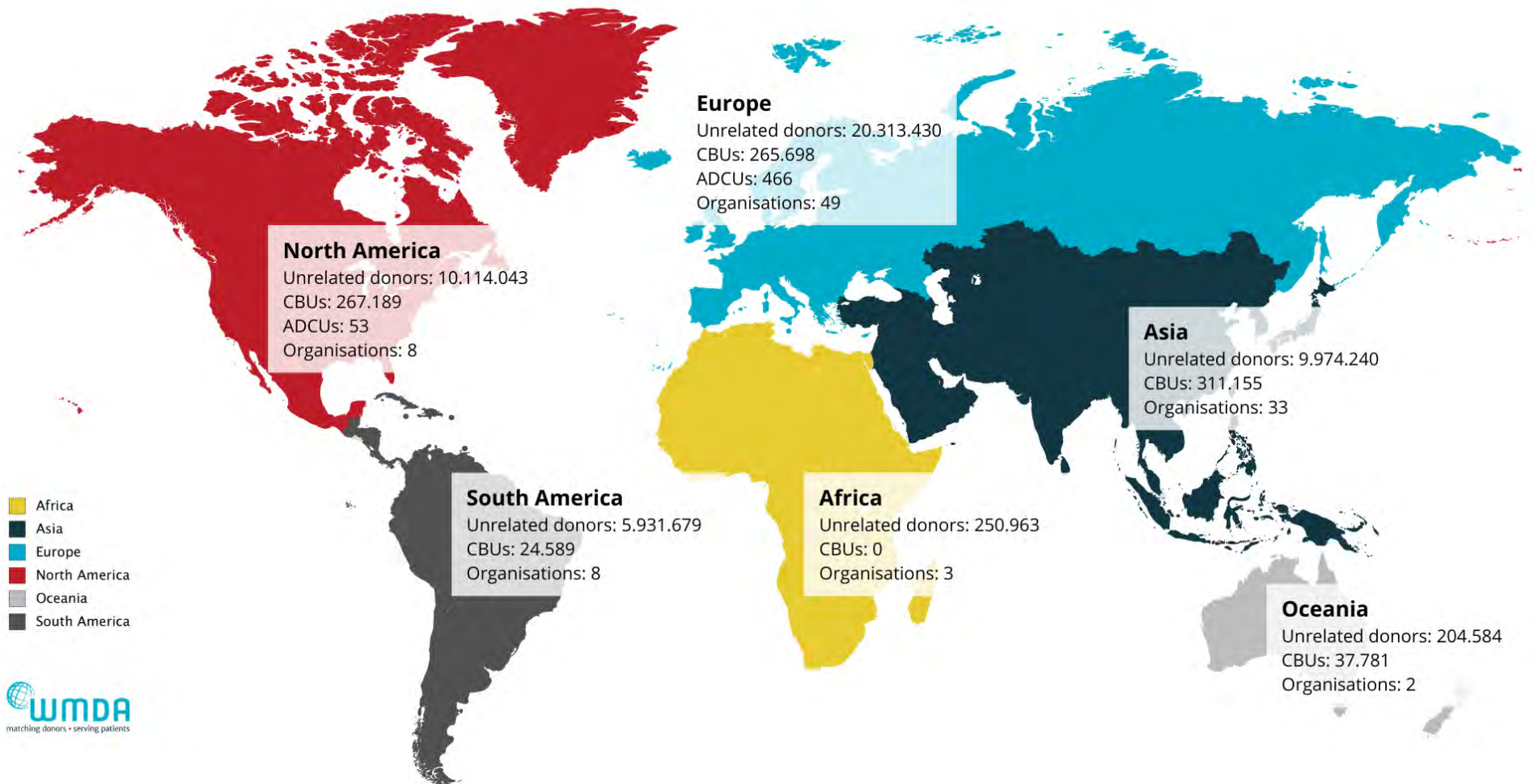

ADCUs available and added to the global inventory in 2025

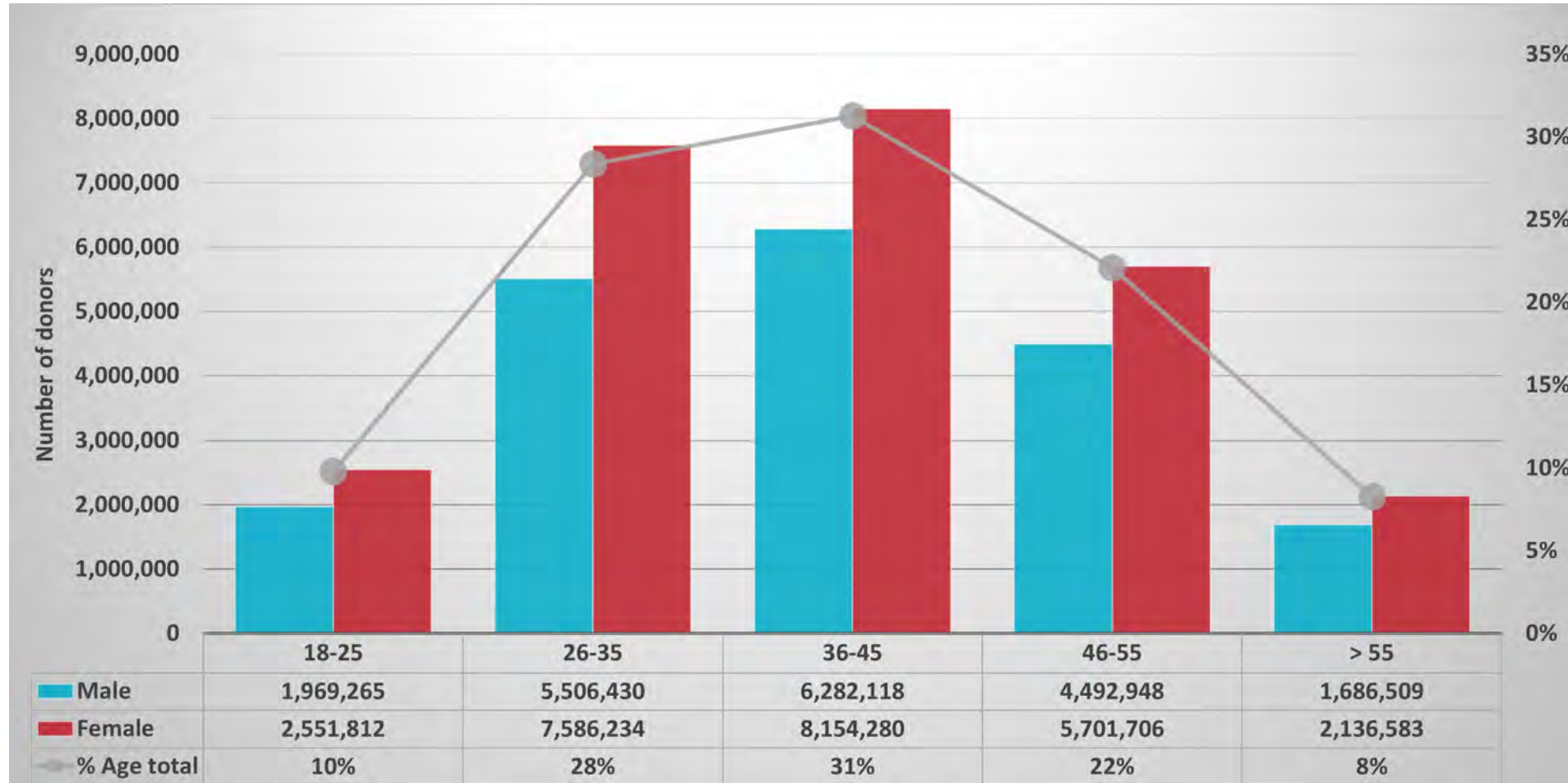


Global inventory of unrelated donor/ADCU/CBU per continent 2025

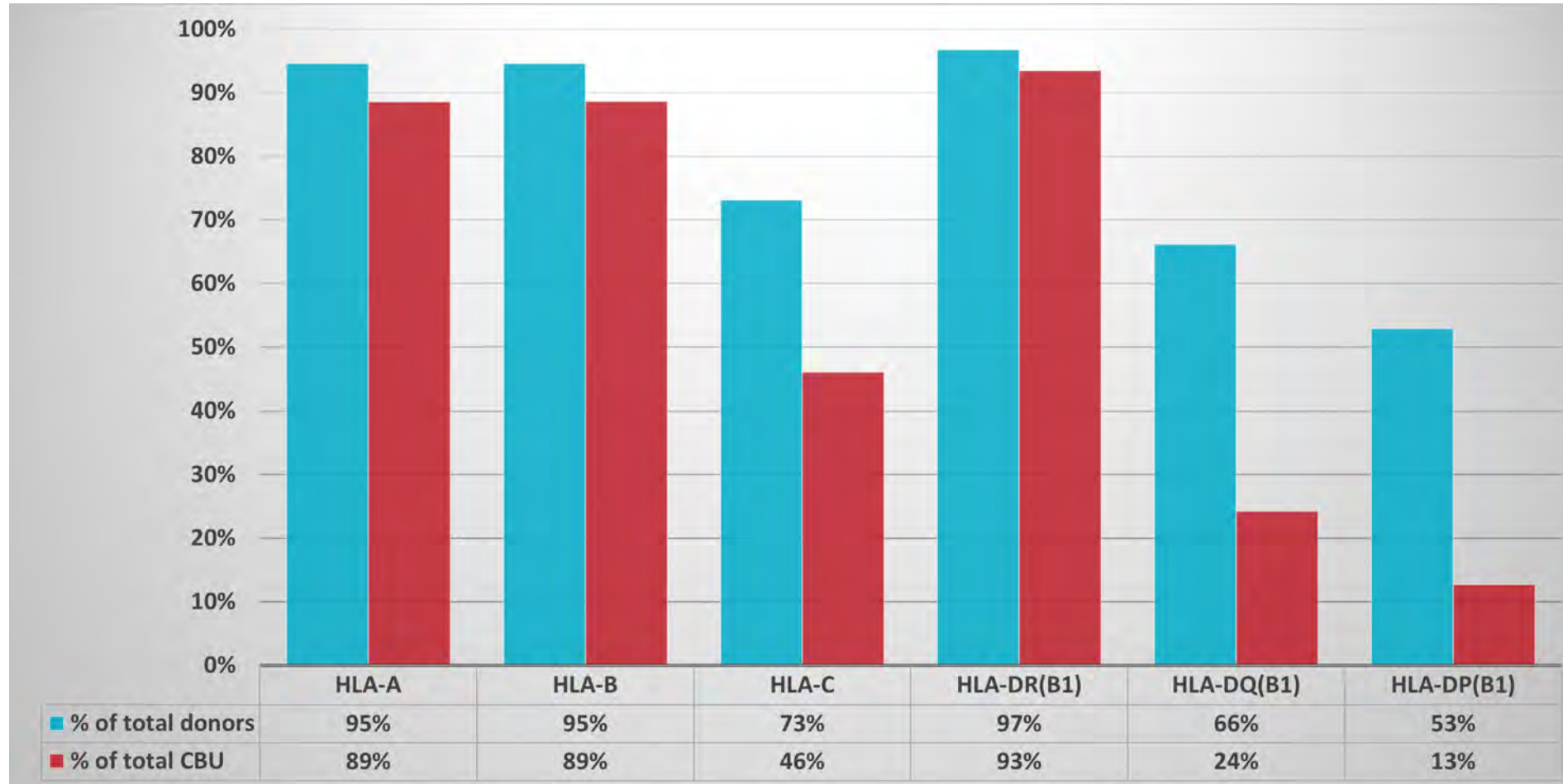
Age and sex distribution of unrelated donors in 2025

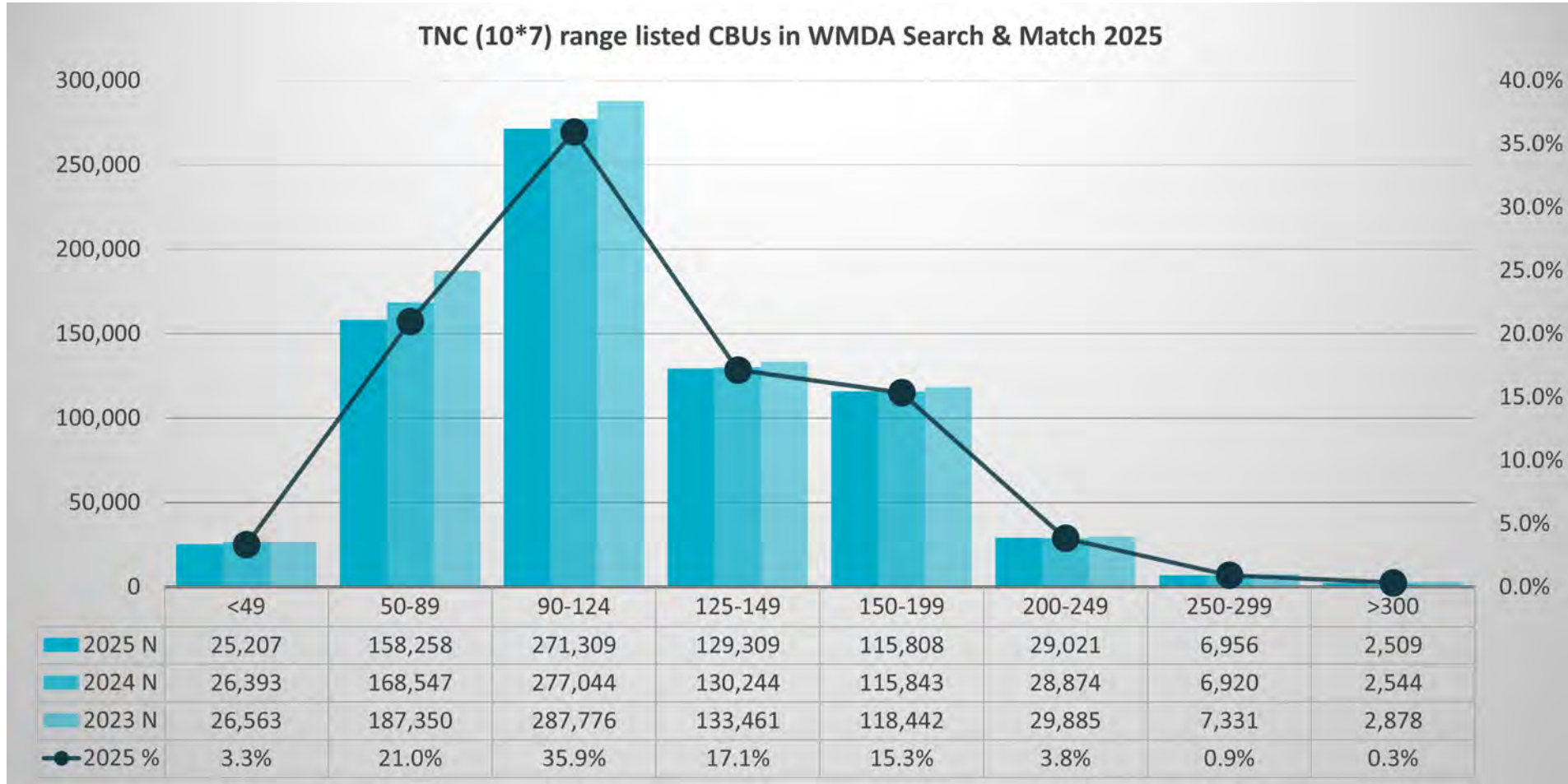

HLA typing (DNA)



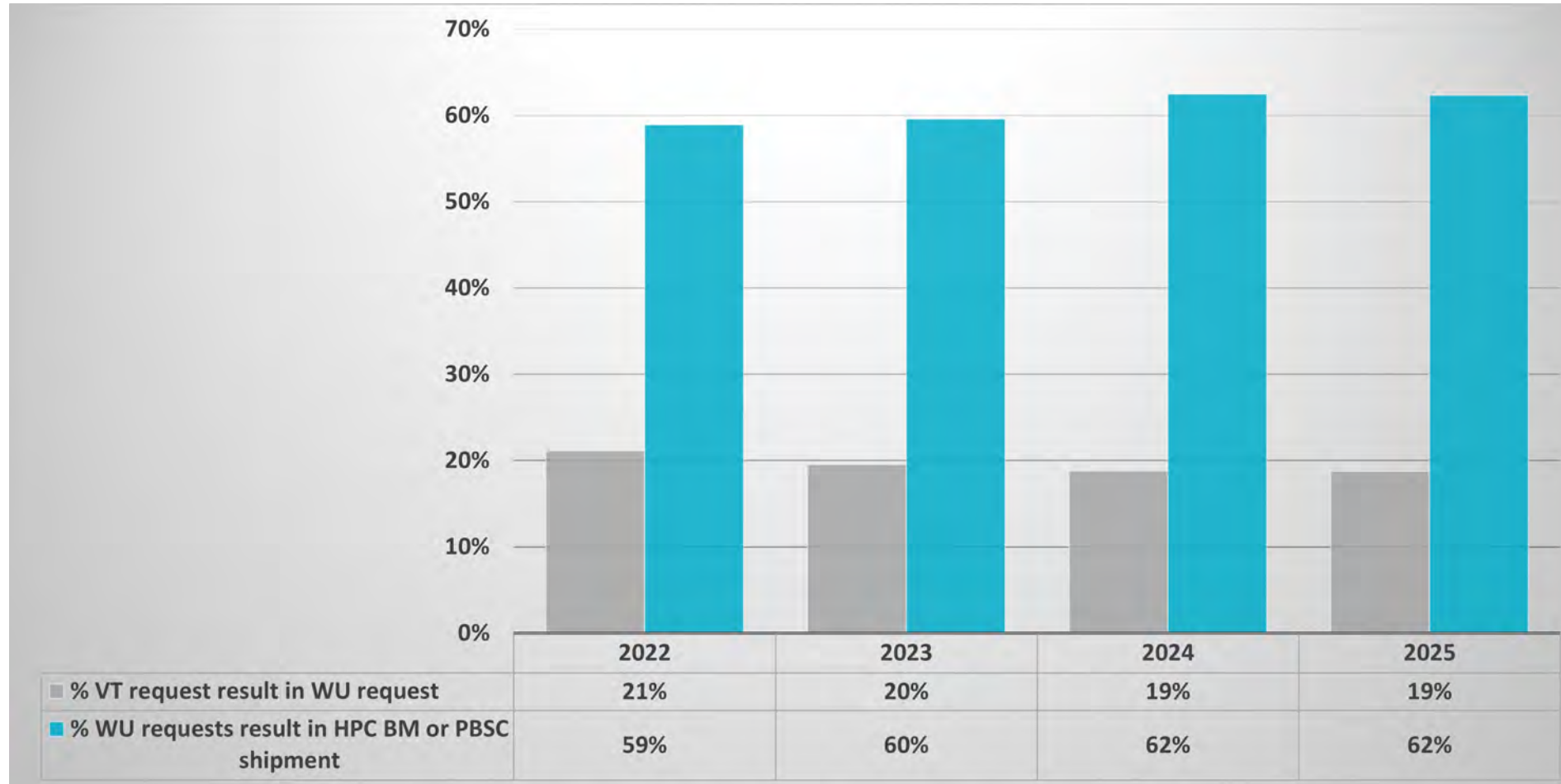

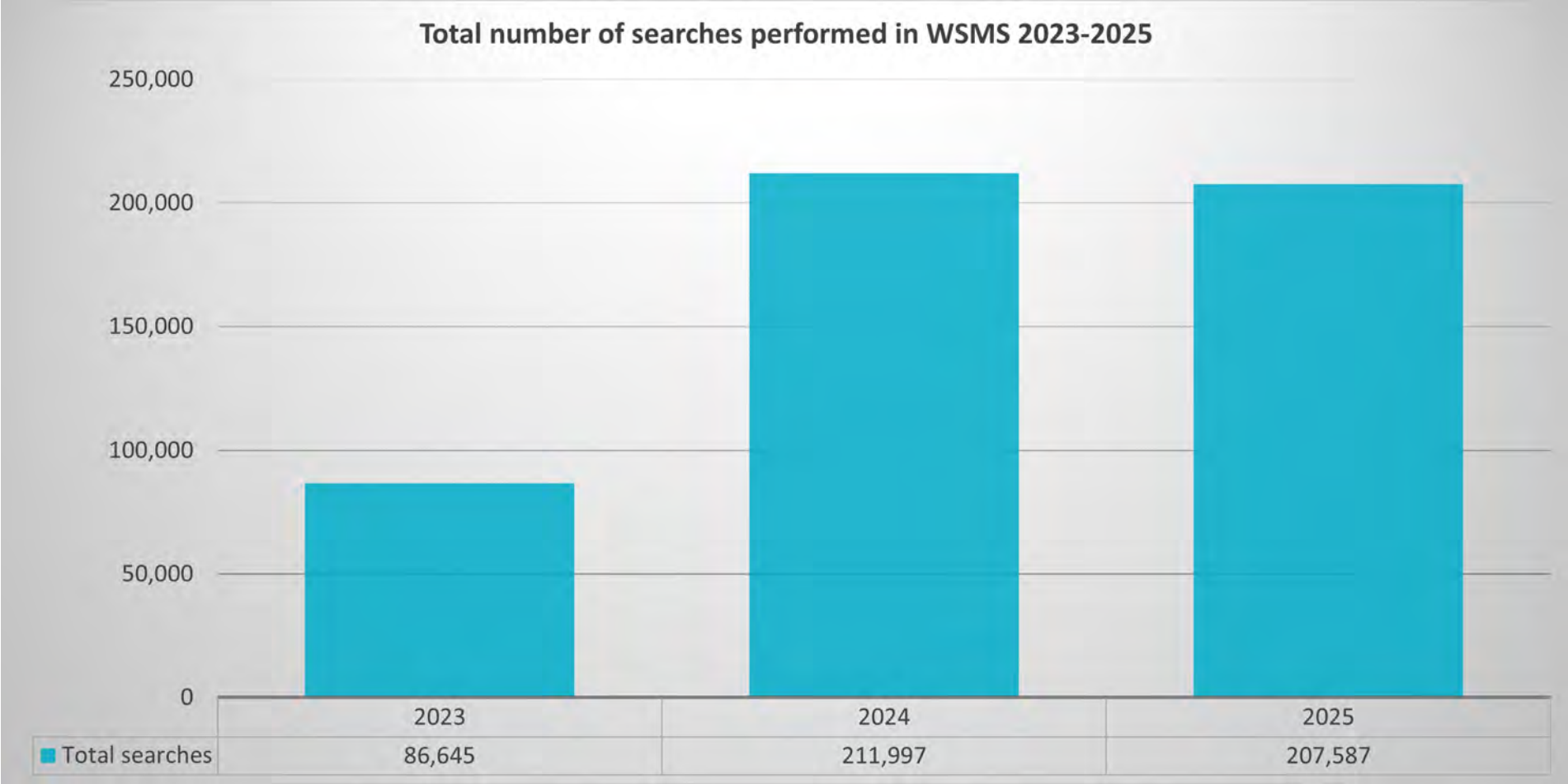

Verification typing, Work up and Shipment completion 2022-2025

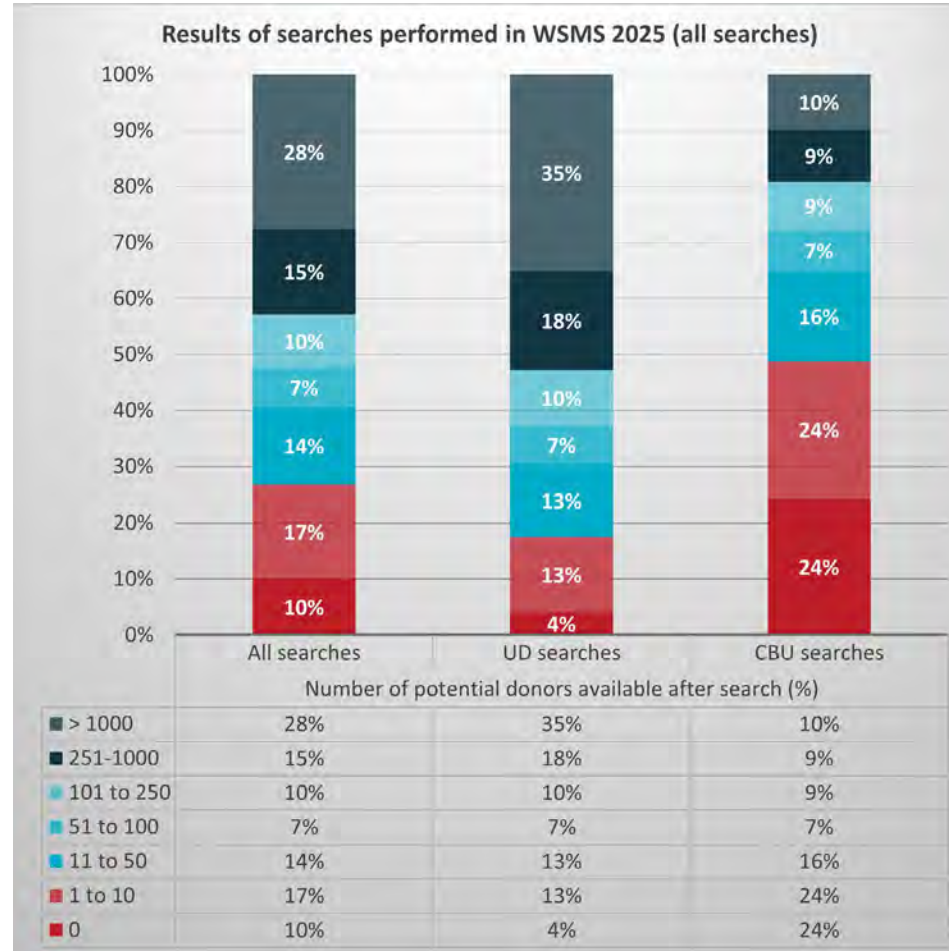


Total searches in WSMS 2023-2025

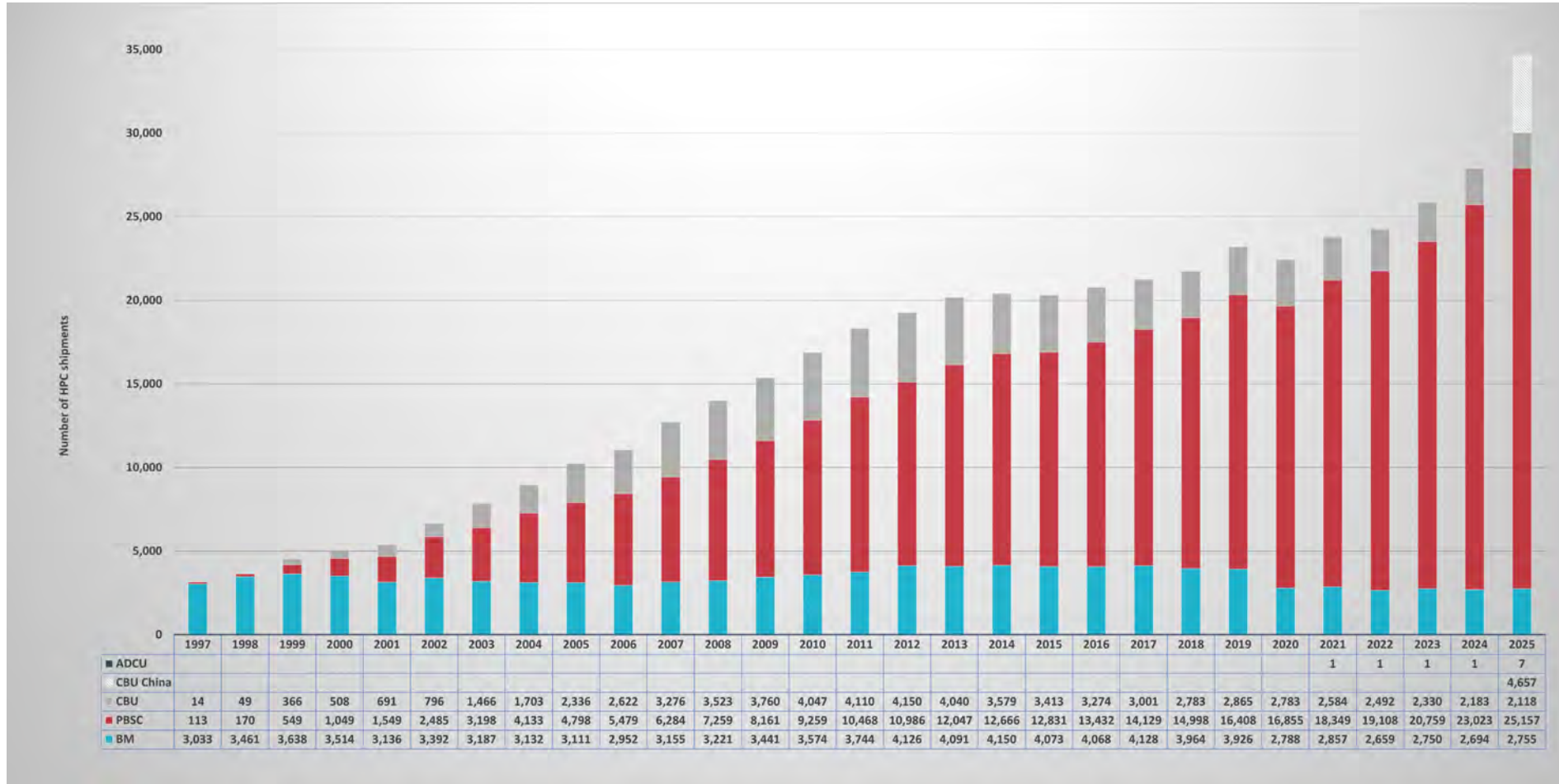

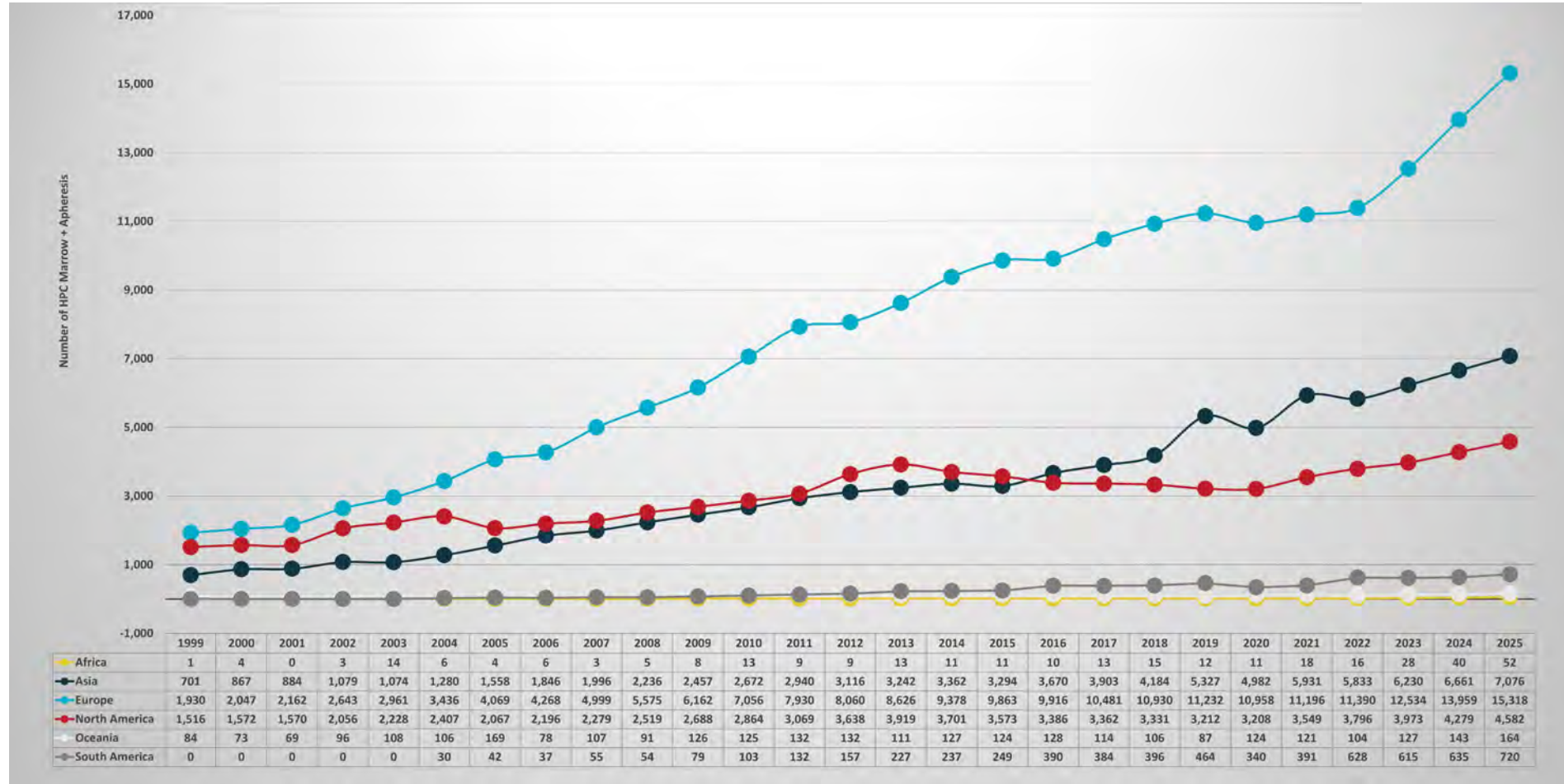

Shipments (BM/PBSC) per continent 2024 vs 2025

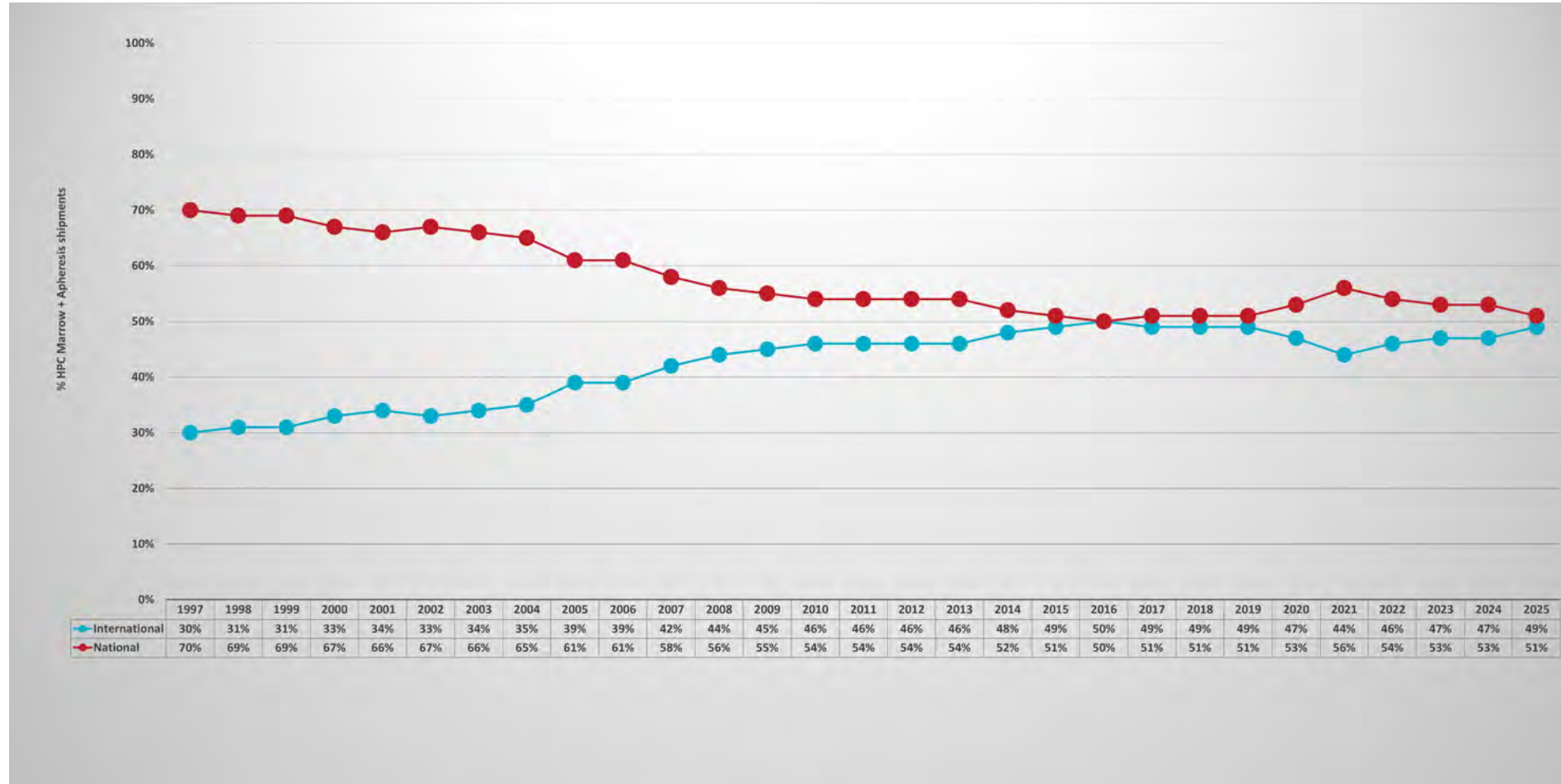

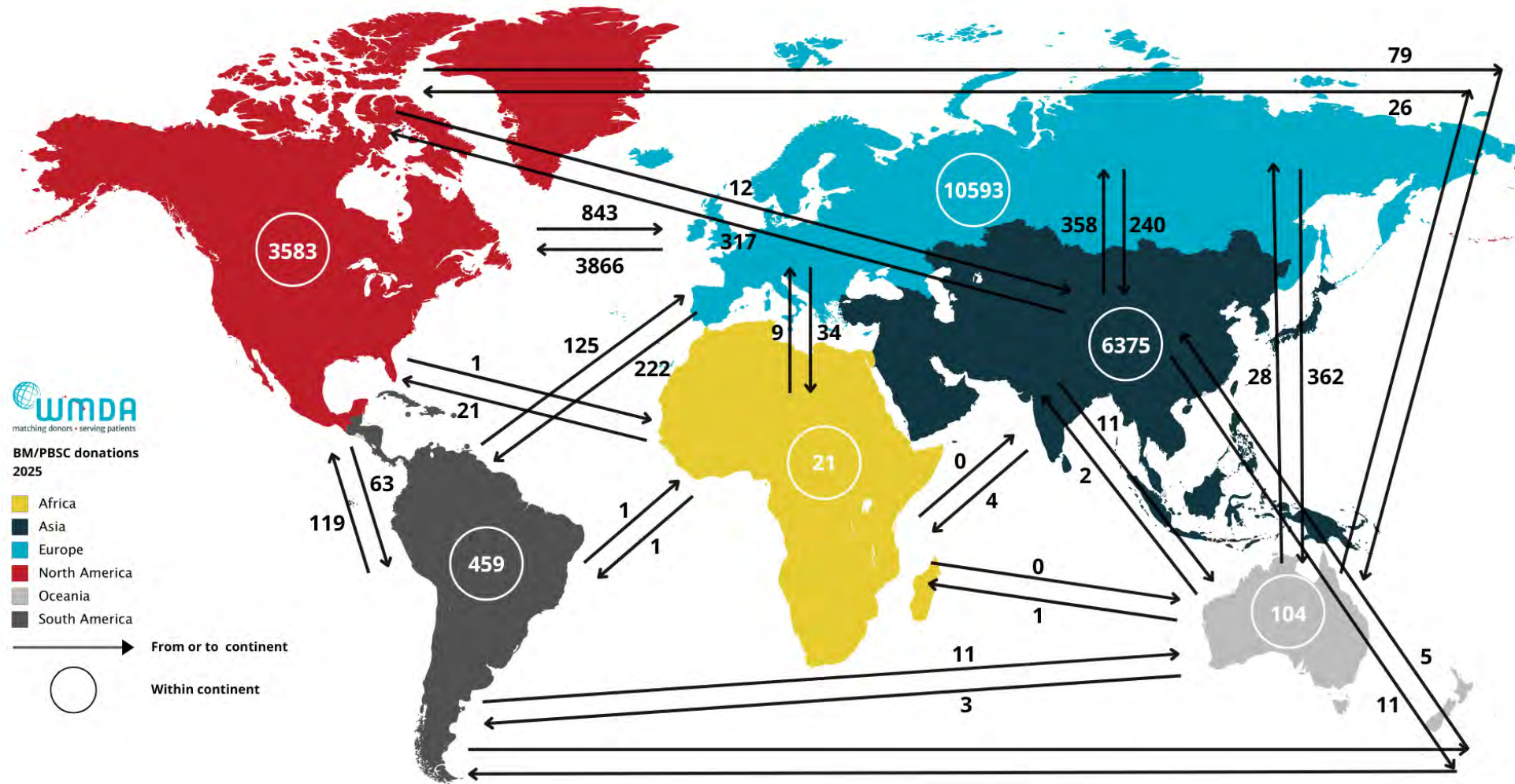

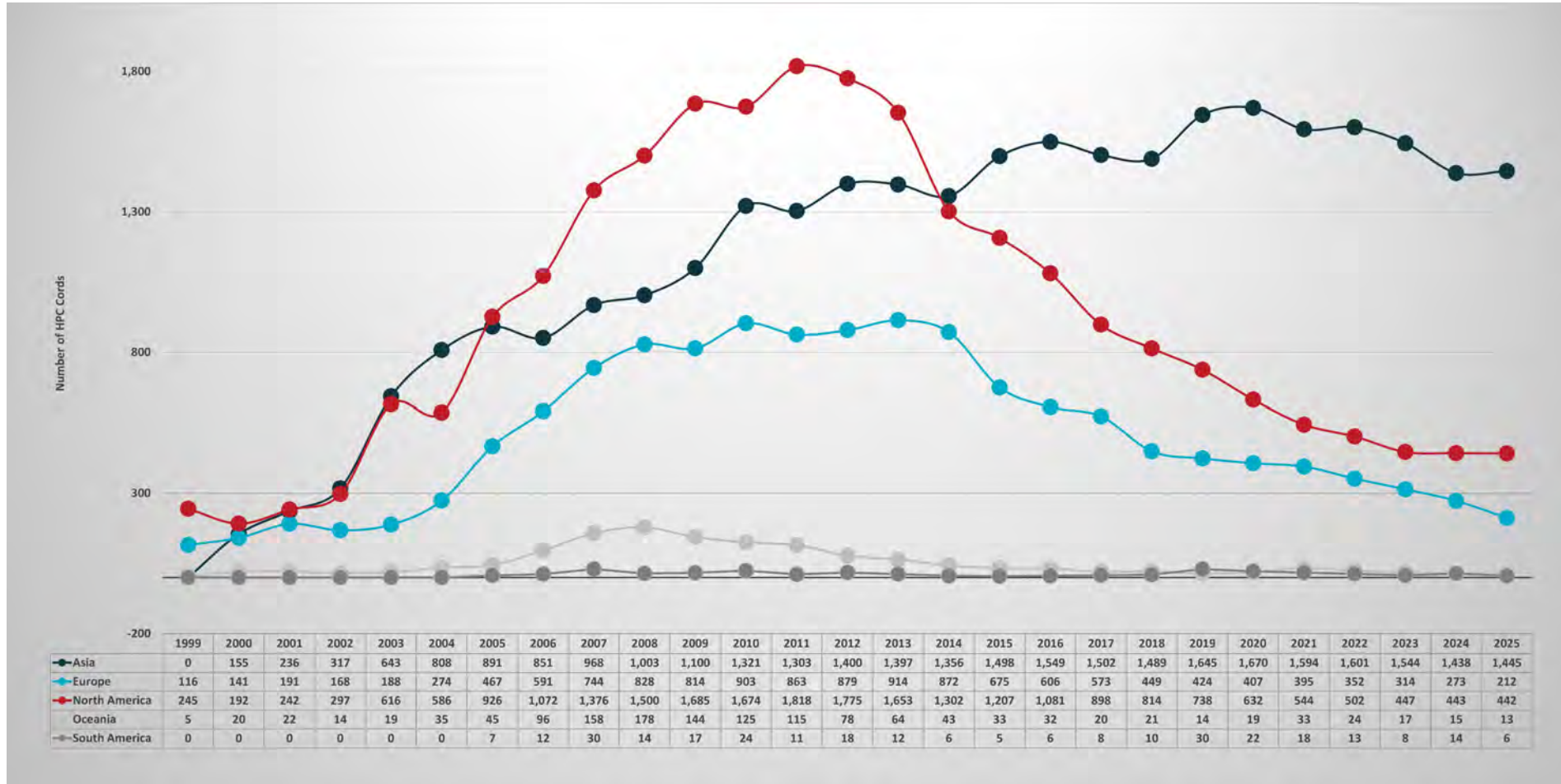
National vs international shipments (BM/PBSC) in 2025

Shipments (CBU) per continent 2024 vs 2025

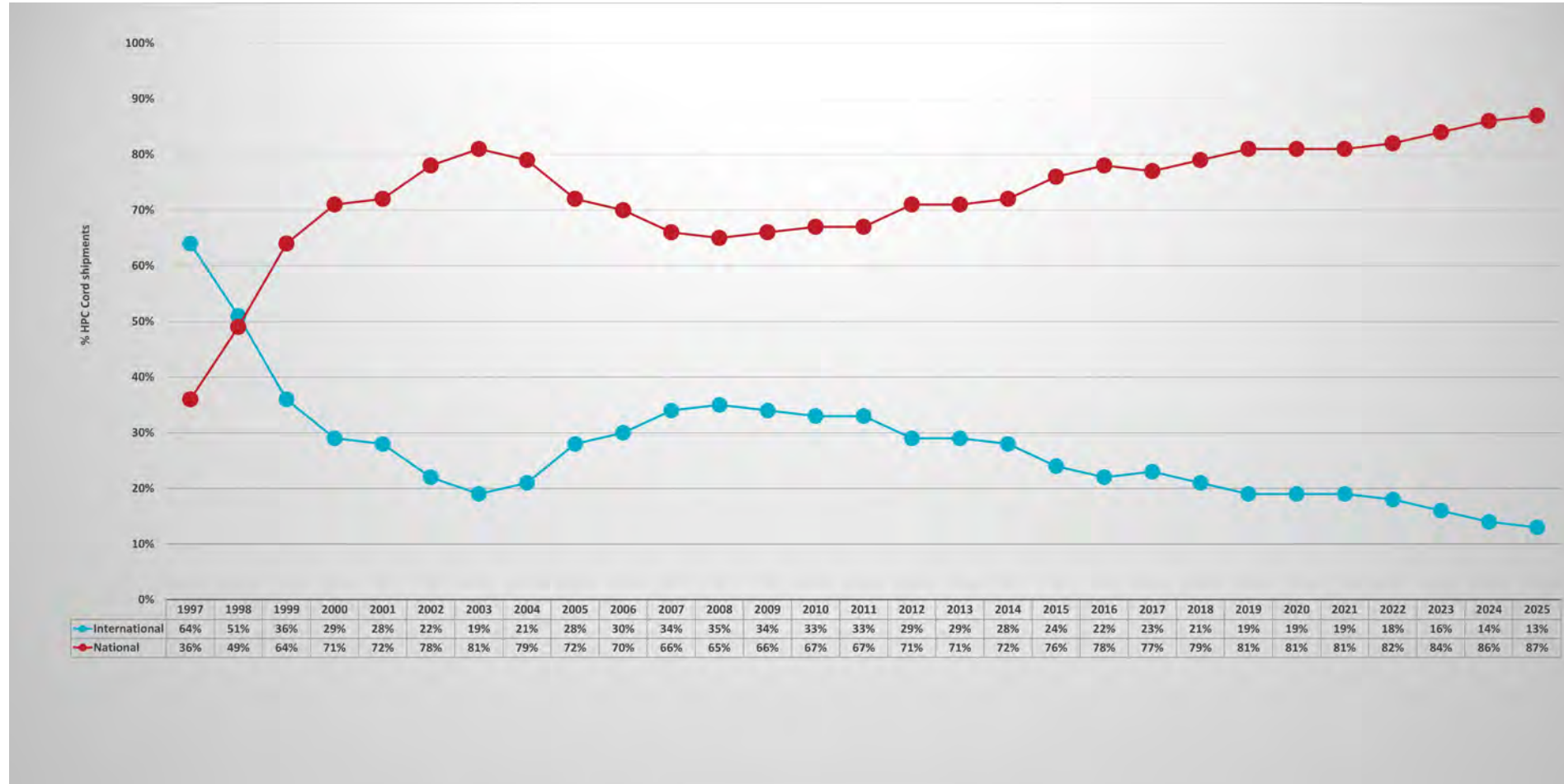

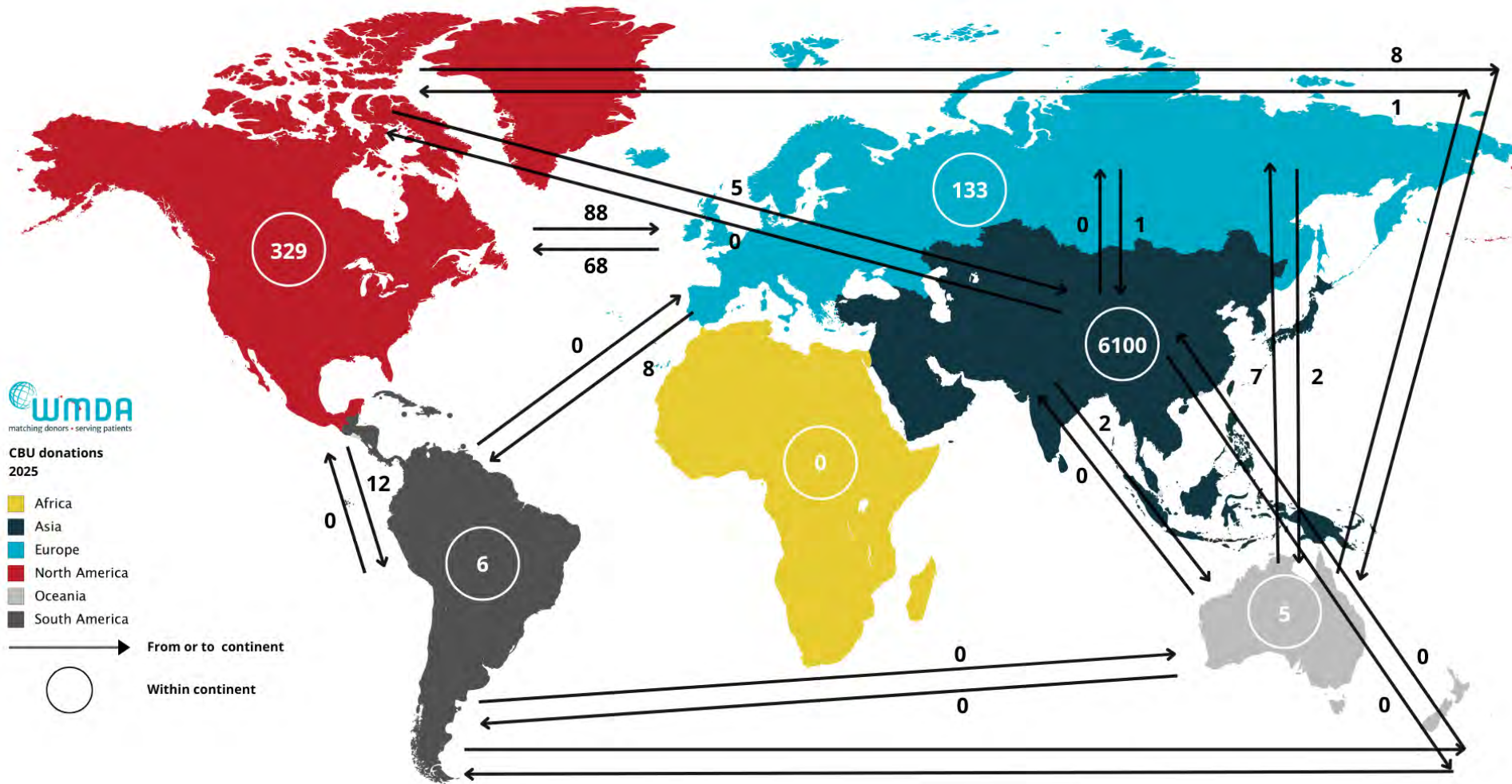

National vs international shipments (CBU) in 2025



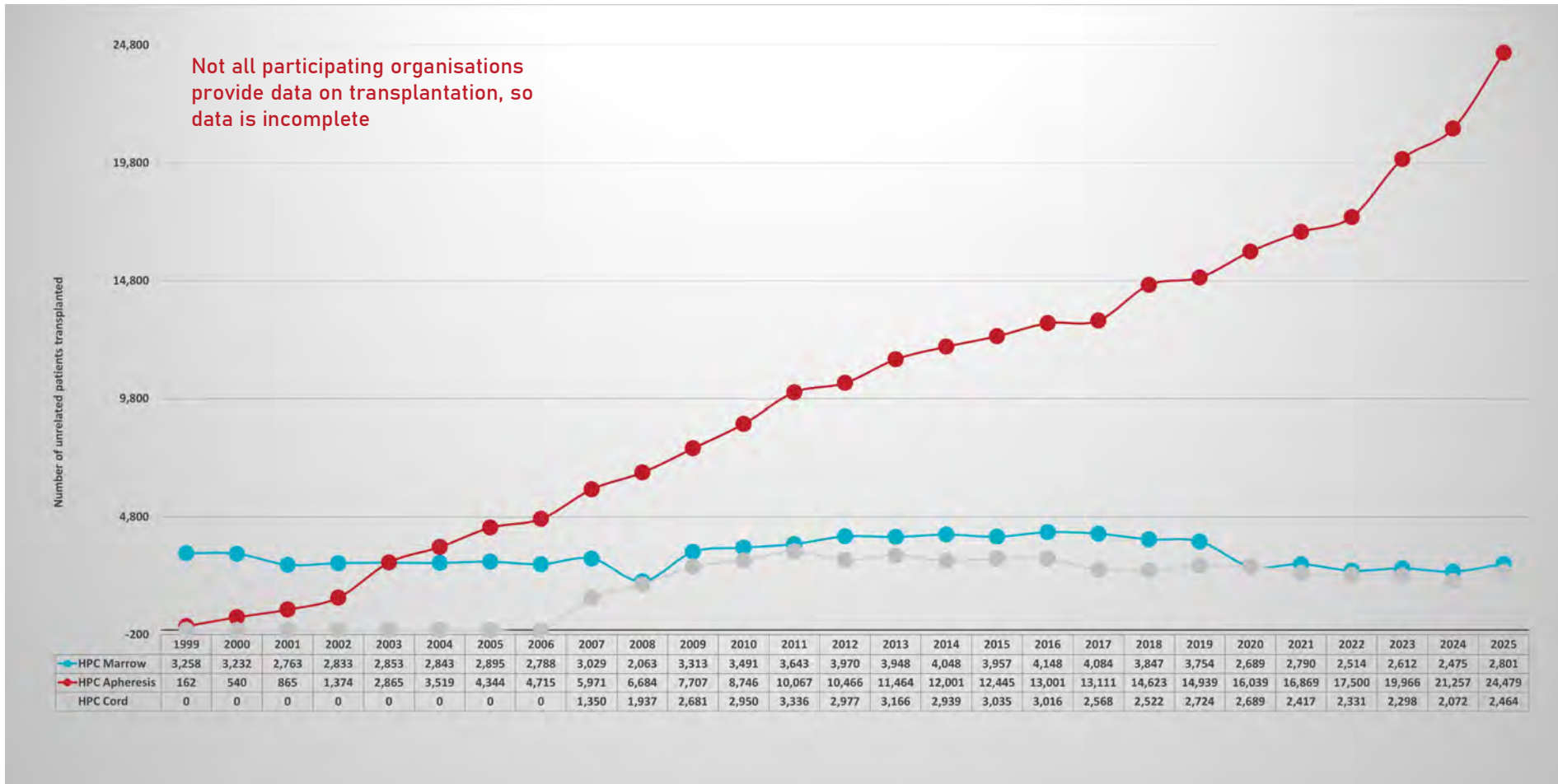

Transplantation 1997-2025



1 CBB in China participated for the first time in 2025. Only 380 (8% of total) out of 4,657 CBUs shipped were used for conventional CBU transplants and are included in this graph. Other transplant options were not possible to be filled out in the questionnaire. The other 4,277 CBUs were used as adjuvant therapy for Haplo transplants (81% of total shipped) or micro-transplantation (10% of total) are not included in this graph
